The meeting this year is possible through a partnership with Dr. Aileen Moreton-Robinson at the National Indigenous Research and Knowledges Network (NIRAKN), Division of Research and Commercialisation at Queensland University of Technology, Brisbane, Australia; Dr. Barry Judd at the Global Indigeneity and Reconciliation Program at the RMIT University, Melbourne, Australia; and the University of Hawai'i at Mānoa. This transoceanic partnership signals the value NAISA places on a global approach to Indigenous studies. We are incredibly excited to see these perspectives reflected in the panels and paper presentations listed in the program. We have also scheduled a variety of events over the lunch break that provides further opportunities for sharing and learning. For me, the highlight of the conference are the huaka'i, which are opportunities for NAISA members to travel to sites across O'ahu in order to meaningfully engage with our larger community.

This event would not be possible without the generosity of our sponsors and the helping hands of the local host committee, volunteers, and community partners. We cannot thank them all here, but know that what we have collectively created is a spirit of abundance that is much needed in the world today. We hope each of you are filled with this waiwai (abundance) and carry it with you after the conference has ended.
